

# Sodium Chloride 5% Eye Drops

# 5% Nacl

# Instructions for use

AabChlor eye drops is a sterile hypertonic solution containing Sodium Chloride 5% that helps to provide temporary relief from corneal edema.

# 1. CONTENTS:

AabChlor eye drops contains Sodium Chloride 5% with the preservative Benzalkonium Chloride Solution, in buffered Isotonic system with neutral pH

**Other Ingredients:** Carboxy Methyl Cellulose Sodium, Boric Acid, Borax.

## 2. CONTRAINDICATIONS:

Hypersensitivity to Sodium Chloride or to any of the ingredients listed above.

#### 3. INTENDED USE:

AabChlor eye drops is a sterile hypertonic solution containing Sodium Chloride 5% that helps to provide temporary relief from corneal edema caused by surgery, infection, trauma or any other eye conditions.

**Warning: DO NOT USE** Except under the advice and supervision of a doctor.

# 4. DIRECTION FOR USE:

Place 1 or 2 drops in the eye(s) as needed.



Get the AabChlor eye drops bottle and mirror.

- Wash your hands.
- Take the bottle and twist off the cap.
- After cap is opened, remove the tamper evident snap collar.
- Hold the bottle, pointing down, between your

thumb and middle finger.

- Till your head back. Pull down your eyelid with a clean finger, until there is a 'pocket' between the eyelid and your eye. The drop will go in here (picture 1).
- Bring the bottle tip close to the eye. Use the mirror if it helps.
- Don't touch your eye or eyelid, surrounding areas or other surfaces with the dropper. It could contaminate the drops left in the bottle.
- Gently press on the base of the bottle to release one drop of AabChlor Eye Drops at a time.
- Don't squeeze the bottle, it is designed so that just a gentle press on the bottom is needed (picture 2).
- If you use drops in both eyes, repeat the steps for your other eye.
- Put the bottle cap back on firmly immediately after use.
- If a drop misses your eye, try again.
- White particles may appear on eye lashes post administration of product if the product oozes out of the eyes. Wipe areas around eye with clean cloth soaked in lukewarm water after administration of AabChlor eye drops if needed.

#### 5. PRECAUTIONS:

- Do not use if allergic to any of the ingredients.
- The dropper tip remains sterile till the bottle is opened
- To avoid contamination or possible eye injury, do not touch bottle tip to any surface and avoid contact with the eye.
- Close the bottle tightly immediately after use.
- Once opened, discard any unused solution after 1 month.

- Do not use after expiry date indicated on the carton & bottle.
- Do not use if package is damaged or the tamper evident seal is broken.
- Discard the solution if it becomes cloudy or brown.
- Store in a dry, dark & well-valented place at a temperature not exceeding 25°C.
- Allow 30 minutes between the administration of other eye drops.
- Remove contact lenses before use.

# 6. SIDE EFFECTS:

**Common:** Eye irritation (Including burning and discomfort), eye pain, eye pruritus and / or visual disturbance.

Blurring of vision immediately after use. Do not operate machinery, use electric tools or drive a car until clear vision is restored.

In the event that you experience side effects not mentioned in this leaflet, or if there is prolonged irritation or severe visual disturbance or any change in your general health, consult your doctor immediately.

If you experience any problems with this product please discuss with your pharmacist, GP or eye care specialist.Do not soak or disinfect your lenses in AabChlor eye drops.

## 7. INSTRUCTION FOR DISPOSAL:

The device should be disposed as per prevailing regulations where the device is used.

# 8. HOW SUPPLIED:

AabChlor eye drops is supplied in 10ml in pack size in a plastic bottle.

Note: This leaflet is specific to AabChlor 5% Eye drops only.
