Instructions for use

Aactive HA 0.1% eye drops is a refreshing lubricant for dry and tired eye developed for rehydration and soothing effect in the eyes. Aactive HA 0.1% eye drops is specially formulated ocular lubricant with unique viscoelastic properties of Sodium Hyaluronate which increases the stability of the pre-corneal tear film and maximizes tear film residence time inside the eyes.

1. COMPOSITION:

Contents: Aactive HA 0.1% eye drops contains Sodium Hyaluronate 0.1% with the safe preservative Stabilized Oxychloro Complex, in buffered isotonic system with neutral pH.

Other Ingredients: Carboxy Methyl Cellulose Sodium, Glycerin, Boric Acid, Borax, Sodium Citrate, Potassium Chloride, Calcium Chloride, Magnesium Chloride, Erythritol, Polyoxyl 35 Castor Oil. May contains Sodium Hydroxide and Hydrochloric Acid to adjust pH.

2. CONTRAINDICATIONS:

Hypersensitivity to Sodium Hyaluronate or to any of the ingredients listed above.

3. INTENDED USE:

Aactive HA 0.1% eye drops is unique formulation of lubricating artificial tear solution used for dry eye sensation. It provides an effective, long lasting lubrication for sore eyes with lasting soothing relief from symptoms associated with dry eyes like itchiness, burning and foreign body sensation caused various non-pathological factors like:

- Visual stress due to prolonged exposure to computer / cell phone screen or television
- Exposure to harsh environment conditions like pollution, dust, smoke, sun, wind or air conditioning.

4. DIRECTION FOR USE:

Place 1 or 2 drops in the eye(s) as needed or as directed by doctor or ophthalmologist.



Get the Aactive HA 0.1% lubricant eye drops bottle and mirror.

- Wash your hands.
- Take the bottle and twist off the cap.
- After cap is opened, remove the tamper evident snap collar.
- Hold the bottle, pointing down, between your thumb and middle finger.
- Tilt your head back. Pull down your eyelid with a clean finger, until there is a 'pocket' between the eyelid and your eye. The drop will go in here (picture 1).
- Bring the bottle tip close to the eye. Use the mirror if it helps.
- Don't touch your eye or eyelid, surrounding areas or other surface with the dropper. It could contaminate the drops left in the bottle.
- Gently press on the base of the bottle to release one drop of Aactive HA 0.1% eye drop at a time.
- Don't squeeze the bottle, it is designed so that just a gentle press on the bottom is needed (picture 2).
- If you use drops in both eyes, repeat the steps for your other eye.
- Put the bottle cap back on firmly immediately after use.
- If a drop misses your eye, try again.
- White particles may appear on eye lashes post administration of product if the product oozes out of the eyes. Wipes areas around eye with clean cloth soaked in lukewarm water after administration of Aactive HA 0.1% eye drops if needed.

5. PRECAUTIONS:

- Do not use if allergic to any of the ingredients.
- The dropper tip remains sterile till the bottle is opened
- To avoid contamination or possible eye injury, do not touch bottle tip to any surface and avoid contact with the eye.
- Close the bottle tightly immediately after use.
- Once opened, discard any unused solution after 28 days.
- Do not use after expiry date indicated on the carton &

bottle.

- Do not use if package is damaged or the tamper evident seal is broken.
- Discard the solution if it becomes cloudy or brown.
- Store in a dry, dark & well-ventilated place at a temperature not exceeding 25°C.
- Allow 15 minutes between the administration of other eye drops.
- Remove contact lenses before use.
- Consult your doctor, pharmacist or optician before you use Aactive HA 0.1% eye drops if:
 - You are pregnant or breast feeding
 - You are suffering from any other eye disease or disorder
 - You are using any other medicine in your eye.

6. SIDE EFFECTS:

Common: Eye irritation (Including burning and discomfort), eye pain, eye pruritus and / or visual disturbance.

Blurring of vision immediately after use. Do not operate machinery, use electric tools or drive a car until clear vision is restored.

In the event that you experience side effects not mentioned in this leaflet, or if there is prolonged irritation or severe visual disturbance or any change in your general health, consult your doctor immediately.

7. EXPECTED GROUP OF PATIENTS FOR OCULAR LUBRICATING & COMFORT SOLUTION:

Children above the age of 5 years, adult & geriatrics population, who are affected by dry eye (such as soreness, burning, irritation or dryness) or dry eye syndrome.

Dry eyes syndrome, also known as chronic dry eye is characterized by a reduced ability to form tears or a reduction in the quality of those tears.

8. WARNING:

If you experience any problems with this product please discuss with your pharmacist, GP or eye care specialist. Do not soak or disinfect your lenses in Aactive HA 0.1% eye drops.

9. INSTRUCTION FOR DISPOSAL:

The device should be disposed as per prevailing regulations where the device is used.















10. HOW SUPPLIED:

Aactive HA 0.1% eye drops is supplied in 10ml in pack size in a plastic bottle.

Note: This leaflet is specific to Aactive HA 0.1% Eye drops only.
